#### 15 Description of Product

The Heat Detector Type DCD-1E-IS is designed to detect combustion products in the air within a hazardous area and provides an alarm indication on a locally mounted LED and to equipment located in the non-hazardous area via a suitable interface.

The DCD-1E-IS comprises various components, including LEDs and a bead thermistor, mounted on a printed circuit board (PCB) which is encapsulated and housed within a plastic enclosure. The heat detector sub-assembly is mounted on a Base Unit Type YBN-R/4IS which incorporates the field terminals. The enclosure provides the electrical circuit with a degree of protection of at least IP20 and the equipment is capable of withstanding a 500V test to earth. Cable entry to the field terminals is from the base of the enclosure.
